

SCHLEY COUNTY BOARD OF COMMISSIONERS
Tuesday, May 12, 2015

The Schley County Board of Commissioners held their regularly scheduled monthly meeting May 12, 2015. Those present were Chairman Greg Barineau, Vice-Chairman Doug Jamieson, Commissioner Sandra Kay Royal, Commissioner Angeli Smith, County Administrator Bill Sawyer, and County Clerk Kathy Bruer. Excused absence: Commissioner Dennis Jones

ITEM 1. CALL TO ORDER

Chairman Barineau called the meeting to order and welcomed all guests.

ITEM 2. APPROVAL OF THE AGENDA

Vice-Chairman Jamieson made a motion to approve the agenda, seconded by Commissioner Royal and all were in favor.

ITEM 3. APPROVAL OF THE MINUTES

Vice-Chairman Jamieson made a motion to approve the minutes from the April 21st meeting, seconded by Commissioner Smith and all were in favor.

ITEM 4. APPROVAL OF THE APRIL 28TH JOINT ZONING MEETING

Commissioner Smith made a motion to approve the Joint Zoning Meeting, Vice-Chairman Jamieson seconded the motion and all were in favor.

ITEM 5. FISCAL YEAR 2015/16 BUDGET PRESENTATION

County Administrator Sawyer presented the Proposed Fiscal Year 2015/16 Budget. Sawyer stated he was pleased there should not be millage rate increase for this year. We will need to schedule two Public Hearings; one in the morning and the other in afternoon to facilitate the community.

ITEM 6. APPROVE/DENIAL FISCAL YEAR 2014/15 BUDGET AMENDMENTS ORDINANCE 05122015B

County Administrator presented the 2014/15 Budget Amendments. Sawyer stated that the law requires us to list and approve any items that were not originally budgeted. Commissioner Royal made a motion to approve the Amendments as presented, Commissioner Smith seconded the motion and all were in favor.

ITEM 7. CONVENTION UPDATE

Commissioner Smith made a presentation and spoke briefly on her attendance to the ACCG Conference in Savannah.

ITEM 8. FINANCIAL REPORTS

County Administrator Sawyer presented the financials for April. Commissioner Royal made a motion to approve the Financials, Vice-Chairman Jamieson seconded the motion and all were in favor.

Item 9. DEPARTMENT REPORTS

Fire Chief Montgomery stated they are halfway done with spraying the hydrants and the pre-fire planning is completed for the year. The Call Volume has been steady.

County Administrator Sawyer stated that the arrears on water is \$5,796.92 and garbage is \$46,157.23. In addition, the Bids opened today for repaving of Green Road. We received two

bids: Reeves \$474,880 and \$8,400 for stripping; Robinson \$303,706 and \$8,820 for stripping. Our next step is to make sure all the paperwork is in order and we will then have a Called Meeting to issue. Sawyer further stated that for about \$88,000 we can widen the Road about two feet on either side.

Item 10. MOTION TO ADJOURN

Vice Chairman Jamieson made a motion to adjourn the meeting, Commissioner Royal seconded the motion and all were in favor. The meeting adjourned at 6:24 p.m.
