

**SCHLEY COUNTY BOARD OF COMMISSIONERS**  
**Tuesday, July 12, 2016**

The Schley County Board of Commissioners held their regularly scheduled monthly meeting July 12, 2016. Those present were Chairman Greg Barineau, Vice-Chairman Doug Jamieson, Commissioner Sandra Kay Royal, Commissioner Angeli Smith, Commissioner Dennis Jones, County Manager, Bill Sawyer and County Clerk Kathy Bruer.

**ITEM 1. CALL TO ORDER**

Chairman Barineau called the meeting to order and welcomed all guests. Commissioner Jones opened the meeting with prayer.

**ITEM 2. APPROVAL OF THE AGENDA**

Vice-Chairman Jamieson made a motion to approve the agenda, seconded by Commissioner Jones and all were in favor.

Lightning struck our Skada system on Lowery Road. We have met with an engineer and have filed an insurance claim.
